However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Professional Services

Basic Services of Director and Staff.....\$2195.00

Our fee for the basic services of funeral director and staff includes, but is not limited to, staff to respond to initial request for service; arrangement conference with family or responsible parties; arrangement of funeral or other disposition; preparation and filing of necessary authorization and permits; recording vital statistics; preparation and placement of obituary notice; coordination with third parties providing other portions of the funeral; e.g. cemetery, crematory, vault companies and others as required. Also included in this charge are the overhead expenses relative to our facility, such as, sheltering of remains, professional licensing, legal and accounting fees, insurance, building and utility expenses, grounds, maintenance, taxes, equipment, furnishings, inventory expenses, record keeping and secretarial and administrative costs. **This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)*

EMBALMING

Except in certain special cases, the law does not require embalming. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with a viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

SPECIAL SERVICES

Forwarding Remains to Another Funeral Home.....\$2995.00

This charge includes basic services of funeral director and staff, transfer of remains to the funeral home, embalming, and local ground transportation to airport. This charge does not include any services or staff for visitation or funeral ceremony prior to forwarding the body, shipping charges or shipping container. (You may add dressing, cosmetic application, casketing, and the casket of your choice.)

Forwarding Remains Outside the Continental U.S......\$4795.00

This charge includes basic services of funeral director and staff, transfer of remains to the funeral home, embalming, and local ground transportation to airport. This charge does not include any services or staff for visitation or funeral ceremony prior to forwarding the body, shipping charges or shipping container. (You may add dressing, cosmetic application, casketing, and the casket of your choice.)

Receiving Remains from Another Funeral Home.....\$2695.00

This charge includes temporary shelter of the remains, the transportation of the remains to cemetery or crematory, and the basic services of funeral director and staff. It does not include visitation, funeral rites, or ceremonies

Immediate Burial..... \$3195.00

This charge includes removal and shelter of remains, local transportation to the ceremony, basic services of funeral director and staff and any necessary authorizations. This charge does not include any attendant rites or ceremonies.

CREMATION SERVICES

Direct Cremation..... \$1895.00

Direct Cremation (300 pounds or more)..... \$2595.00

Our cremation charges include the basic services fee of funeral director and staff, transportation of remains, shelter, all necessary authorizations, and local transportation to the crematory. It does not include embalming, facilities for viewing or funeral ceremony, permits or merchandise. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The purchase of an alternative container or casket is not required for direct cremation.

Total Funeral Bill: We are a small business providing services and merchandise and are totally dependent upon our clients for prompt payment. Our payment terms are:

- Valid insurance policies are accepted along with a 6% processing and brokerage fee.
- Credit card payments are accepted with a 3.5% processing fee.
- Money Orders or Certified Checks are accepted.
- Down payment of 50% due at contract signing; all payments must be made in full 72 hours prior to burial or cremation.
- A cash advance (monies paid to third parties on your behalf to help facilitate the funeral) represents an interest-free cash outlay on the part of the funeral home; therefore, all cash advances must be paid at the time of the arrangements.
- A late fee of 1.5% will be added every 30 days for outstanding invoices.
